respect of which meetings proper notices were given and the proceedings have been properly recorded in the Minutes Book/Registers maintained for the purpose and the same have been signed during the year review.


5. During the year under review, the Company was not required to close the Register of Members.

During the year under review, the Company has allotted shares and the share certificates were issued and dispatched in compliance with the prescribed time limits under the Act pursuant to Right Issue. There was no transfer, transmission, conversion of shares and as such the Company was not required to issue /dispatch shares certificates.

12. The Board of Directors of the Company has been duly constituted. There were no instances of filing up casual vacancies of Directors. The Company has duly made the appointment and re-appointment of Directors during the year under review. During the year under review following changes were made in Board of Directors of the Company:



- Mr, Sudhir Shah ceased to be Director of the Company w.e.f. 07th September, 2021.
- Mr. Raj Pal Sharma ceased to be Director of the Company w.e.f 04th August, 2021.
- Mr. Samir Kumar Barua was appointed as Additional Director of the Company w.e.f. 01st October, 2021.
- Mr. Pradip Kanakia was appointed as Additional Director of the Company w.e.f. 01st October, 2021.

All the Directors and Key Managerial Personnel of the Company have disclosed their interests as required under section 184 of the Act read with Rule 9 of the Companies (Meetings of Board and its Powers) Rules, 2014.

13. The Company has duly made the appointment of the Auditors as per Section 139 (6) of the Act during the year under review.
14. The Company was not required to take approval from the Central Government, Tribunal, Regional Director, Registrar, Court or such other authorities under the provisions of the Act during the year under review.
15. The Company has not accepted or renewed deposits during the year under review.
16. Being private limited company, provisions of Section 180 of the Act are not applicable.
17. The provisions of Section 186 of the Companies Act, 2013 are not applicable as the Company is engaged in the business of providing Infrastructure Facilities as specified in Schedule VI to the Act.
18. During the year under review, the Company has altered the Clause 5 of the Memorandum of Association in respect of increase in Authorised Share Capital from Rs 11,00,00,00,000/- (Rupees One Thousand One Hundred Crores only) divided into 1,10,00,00,000 (One Hundred Ten Crore) Equity Shares of Rs. 10/- each (Rupees Ten only) to Rs 21,00,00,00,000/- (Rupees Two Thousand One Hundred Crores only) divided into 210,00,00,000 (Two Hundred Ten Crore) Equity



Shares of Rs. 10/- each (Rupees Ten only) vide Ordinary Resolution passed at the Annual General Meeting held on August 04, 2021.

During the year under review, the Company has not altered Articles of Association of the Company.
